/1 Councillor L Hagues – May Newsletter shared. Cllr Hagues shared that her husband has raised £3428.25 for the farmer.

/2 Councillor M Overton – May Newsletter shared. Cllr Overton was not in attendance.

/7 To consider matters for discussion and resolution

to provide an update on Fosse Green and Springwell Farm including Coleby batteries (Cllr Mountjoy/Cllr Reid)

a debate has been arranged for 15th May 2025. Details have been shared with the

Parish Council. Navenby Parish Council have shared the details of the Planning Application for the Electric Sub Station. ONGOING

to discuss the church floodlights and approve prices for the purchase of 3 lights (Chair)

4 lights were purchased in 2021, they had 50,000 hours. 3 floodlights have failed. The Chairman proposed the purchase of 3 new lights for £80 each, that will need to be fitted by an Electrician. The Parish Council unanimously agreed the purchase and fitting. Item Closed.

to provide an update on grounds maintenance provided by NGMS including hedge trimming and the requirement for a hedge trimmer (Cllr Hausermann)

Cllr Hausermann has spoken to NGMS re the works around the village. There is a hedge trimmer that is rechargeable, Cllr Shaw will locate the hedge trimmer and works will be carried out in the short term by Cllr Hausermann. Item Closed.

to provide and update on the Wellingore Timeline and Millennium works (Cllr Hathaway)

The friends of the church are reluctant to have the timeline duplicated at another place in the village as they want to keep it in the church to encourage people to visit. The Parish Council will engage with the church to determine if they are interested to have any input into doing a local interest trail incorporating the timeline. If they are not interested it is unanimously agreed that the Parish Council will pursue the project. ONGOING

to provide an update on the Navenby FC request for football at Memorial Hall Field (Cllr Hausermann)

The parish council are awaiting the contract from Navenby FC. It was suggested that if Navenby FC cut the whole field, then there will be no charge for the use of the pitch. ONGOING

to discuss the donation from the Residents Association for the purchase of a bench (Parish Clerk)

£600 has been donated by the Residents Association for the purchase of the bench. They have requested the wording for a plaque to be placed on the bench. A picnic bench was agreed for the far side of the field.
