VILLAGE HALL FUNDING

The government has announced that the Platinum Jubilee Village Hall Fund had opened for applications. The fund is managed by the charity Action with Communities in Rural England (ACRE) and village halls in England can now apply for grants to improve and modernise their facilities.

Village halls interested in applying can request grants from £7,500 to £75,000, and up to a maximum of up to 20% of eligible project costs. Capital grants will be allocated to support infrastructure improvements, the refurbishment of facilities, such as kitchen and toilets, and measures to improve energy efficiency.

Please note that to be eligible the village hall must serve a community with population below 10,000 people and must be registered as a charity with community management.

The application window will close on 20th January 2023, with successful applicants being able to draw on the funding from April 2023.

CHRISTMAS WASTE AND RECYCLING

Changes to bin collection dates over the Christmas and New Year period will only affect customers used to having their bins collected on a Monday.

Monday customers will need to follow the same routine as normal when a bank holiday falls on a Monday and put their respective bins on the preceding Saturday instead. Bins due to be collected on January 2nd will be collected on December 31st.

Side waste next to bins is unable to be collected, however households can take any additional waste instead to their local Household Waste Recycling Centre. For opening times see Lincolnshire.gov.uk/recycling-waste

Garden waste customers are reminded that collections of these bins reduce in December and January. There shall be no garden collections between the period of Monday December 19th through to Friday January 13th. Collections shall resume again from week commencing 16th January 2023.

COMMUNITY TAI CHI SESSIONS

On 25th November, North Kesteven Community Team from GLL (their leisure providers) hosted a Tai Chi session in Heckington Village Hall.

Heckington was selected because 66% of the parish population do not achieve the minimum WHO guidelines for activity, which are 150 minutes of moderate activity a week (or 75 minutes of vigorous activity). A whopping 45% of the parish population do not complete 30 minutes of activity a week!

Whilst a fantastic service is offered in their leisure centres, not everyone is able to travel to those locations. GLL aim to branch out further and offer services/sessions to people in their local communities, ensuring those who find it difficult to travel don't miss out. NEW FUNDING REINVIGORATES UKRAINE APPEALS

The Lincolnshire Community Foundation is pleased to announce the re-launch of the "Big Lincolnshire Welcome Fund", alongside the new introduction of the "Ukrainian Refugee Intergration Fund".

This is thanks to a £150,000 funding boost from Central Government's Homes for Ukraine scheme via Lincolnshire County Council.

Funding is available to give a displaced person from Ukraine the opportunity to choose for themselves what item(s) up to the value

of £150 for any individual or £300 for a family unit, they need to make their lives better here in Lincolnshire. More than 50 Ukrainian guests accessed the fund earlier in the year and this new funding will allow even more people to benefit. For a full guidance and details how to apply, please visit the Lincolnshire Community Foundation website. Please note that the new applications will be reviewed from this month January 2023. Ukrainian Refugees Integration Fund opens for community group applications. Grants of up to £10,000 will be available to any new, emerging, or existing community groups and not-for-profit organisations in Lincolnshire to strengthen their ability to support Ukrainian refugees and help them better integrate into local communities. Project funding will be awarded to those requests that help reduce isolation, vulnerability and promote cohesion; meaningful activities which have a positive impact on mental health and wellbeing; support around employment and learning, including English language lessons. The closing date for receipt of completed bids for the first round of funding is 31st January 2023.

ROUGH SLEEPERS: SEVERE WEATHER EMERGENCY PROTOCOL

Help is available for rough sleepers across North Kesteven during the winter months with their annual SWEP provision (Severe Weather Emergency Protocol) and other services.

The co-ordinated resource of Change for Lincs, their local Rough Sleeper initiative, supports North Kesteven, West Lindsey and South Holland and provides specialist services for those who may be street homeless or at risk of street homelessness. Our housing Options Team works in partnership with Change 4 Lincs to identify for all those who may require emergency assistance and assure this is made available, together with appropriate advice and support in terms of any statutory homelessness duties that NKDC will provide.

NKDC aim to provide an emergency placement for any person with a local connection who may be sleeping rough and where from another District, they support to reconnect them to appropriate services.
